2.6	Alternative Bids	<p>The bidder’s offer shall be strictly in accordance with the technical specifications specified in proposal.</p> <p>Additionally, bidders can propose an alternative to the offer if they consider it economically and technically interesting for MAG, by indicating very precisely the differences that it presents compared to the specification standards.</p> <p>Alternative tenders must be submitted as a separate tender proposal. If you are proposing more than one vehicle for a particular Lot, please fill out a new Pricing Document for each submission.</p>
2.7	Prices	<p>MAG does not bind itself to accept the lowest tender. All prices quoted shall be <i>exclusive</i> of Value Added Tax (VAT) or other locally applicable taxes.</p> <p>Suppliers must hold prices firm for a period of 6 months. If there are to be any price increases after this time, they must be agreed in writing with MAG, and MAG must be given 30 days written notice.</p> <p>Should a supplier wish to change a price based on significant fluctuations to the exchange rate, the formula for price revision is indexed to the average monthly or annual exchange rate of the dollar against the currency the invoice is paid in. MAG uses the <a href="#">European Commission</a> Monthly Exchange rate.</p> <p>Any orders made by MAG are to be accepted at the agreed price on the date of the order.</p> <p>Any quotations provided, outside the agreed prices in the tender, must be held firm for a period of 30 days.</p>
2.8	Currency Unit	<p>All prices shall be expressed in USD and be free of VAT. This is to allow for a fair comparison of prices. Following the award of the contract the working currency will be decided between MAG and the contracted party.</p>
2.9	Bidding for Lots	<p>Bidders must tender for complete Lots since Lots constitute coherent product groups.</p>

<b>3</b>	<b>Submission and Opening of Bids</b>	
<b>3.1</b>	<b>Scope of Agreement</b>	<p>MAG intends to issue a 24 months (2 year) Framework agreement with Preferred Suppliers for all Lots. This may be extended by a further 12 months subject to agreement by both parties.</p> <p>The same bidder may be awarded more than one Lot.</p> <p>MAG also reserves the right to appoint more than one supplier per Lot.</p> <p>Bidders must ensure they indicate which Lot(s) they are bidding on in the <b>Supplier Registration Questionnaire, Section 16: Indication of Bid</b>.</p> <p><b><u>Tenderers are permitted to submit bids for either one Lot or as many Lots as they wish to provide.</u></b></p>
<b>3.2</b>	<b>Signing of Bid</b>	Tender documents shall be signed by an authorised signatory of the bidder.
<b>3.3</b>	<b>Deadline</b>	<p>Tenders received after the closing date will not be considered, unless in MAG's sole opinion there are exceptional circumstances that justify a delay.</p> <p>Deadline for submission of complete offer is: <b><u>04/10/2024 17:00 BST</u></b></p>
<b>3.4</b>	<b>Compliance</b>	MAG reserves the right to reject all tenders not submitted in the format specified.
<b>3.5</b>	<b>Right to reject all tenders</b>	MAG is under no obligation to accept any tender.
<b>3.6</b>	<b>Right to accept part of a tender</b>	MAG may, unless the bidder expressly stipulates to the contrary, accept whatever part or parts of an offer MAG desires.

4.3	<b>Stage 2a</b> <b>Tender Proposal Analysis –Service Quality</b> <b><u>50% Weighting</u></b>	<p>The following criteria will be assessed:</p> <ul style="list-style-type: none"> <li>Quality of Service and Support</li> <li>Technical offer and machine suitability</li> <li>Lead Times</li> <li>Ability to arrange shipment of Machines</li> <li>Value Added Services</li> </ul>
4.4	<b>Stage 2b</b> <b>Tender Proposal Analysis –Pricing</b> <b><u>40% Weighting</u></b>	<p>The following criteria will be assessed:</p> <ul style="list-style-type: none"> <li>Pricing</li> </ul>

4.5	<b>Site Visit / Presentation</b>	As part of the tender process, a site visit by a member of the MAG staff, and/or a short presentation by the bidder at MAG premises or via conference call may be required.
5	<b>Award of Agreement</b>	
5.1	<b>Award</b>	The agreement shall be awarded to the tender(s) offering the best value for money, that is to say, the best price-quality ratio, in compliance with the principles of transparency and equal treatment for potential suppliers.

<b>5.2</b>	<b>Purchasing conditions</b>	All agreements entered into as a result of this tender will be subject to MAG's Service Level Agreement unless expressly agreed otherwise in writing.
<b>5.3</b>	<b>Review Process</b>	There will be a formal progress review meeting three months after the signing of the agreement, between the winning bidder's designated account manager and MAG.
<b>5.4</b>	<b>Preferred Supplier(s)</b>	Although the successful bidders will become the preferred supplier(s) for these items, this tender will not constitute an exclusive agreement and if the supplier cannot meet the stipulated lead time or specification requirements then another supplier shall be sought by MAG for that requirement.
